This Information Disclosure was issued in Jakarta on **September 25, 2019**.

INTRODUCTION

The Bank has issued a Negotiable Certificates of Deposit ("NCD") on September 25, 2019, with a total issuance size of Rp2.390.000.000.000 (two trillion three hundred and ninety billion Rupiah) in 4 tranches: 3 months, 6 months, 9 months and 12 months.

PURPOSE

Use of proceeds from the NCD issuance will be used by the Bank for loan expansion purposes to support business growth.

DESCRIPTION

The Bank has issued a Rupiah denominated NCD under the name of “Negotiable Certificates of Deposit (“NCD”) III BNI Tahun 2019” with a total issuance size of Rp2.390.000.000.000 (two trillion three hundred and ninety billion Rupiah). The NCD is scripless, with the final structure as follows:
